BFSN Restart Committee's work & progress was presented.

City of Houston District G Report: Council Member Mary Nan Huffman

Approximately 250,000 people reside within District G.
Sarah Jones, Assistant to CM Huffman, was introduced.

Safety:

- HPD & Mounted Patrol will be out on Halloween. Anyone who sees something suspicious is asked to contact HPD.
- New crosswalks (2) have been installed on Wilcrest for safer access to Terry Hershey Park.
- Flock Cameras have been installed in several locations in District G.
- Crime report:
 - Violent crime decreased 9.64% since last year.
 - Non-violent crime decreased 3.89% since last year.
 - Murders: 350 last year vs. 288 YTD.

Infrastructure:

- Kirkwood Rebuild Phase 2 has started. Trees are being marked. Forty-four trees will be removed; 34 will be planted.
- Water leaks: City Council has approved \$59M for water leak repairs. Twelve contractors have been hired. The leak at Briar Forest & Crystal Hills was repaired and the resulting hole was filled earlier this month. Replacement of that section of road has been approved and is expected soon.
- Houston's 311 System has been upgraded. (One new feature is the ability to drop a location pin.) 311 contacts are not automatically sent to the District G office. ** Please email District G office with the reference # so they can follow up.
- Road projects completed in District G YTD: 47.
